

# Synopsis

This one-day course provides a simple explanation to the IEM Form of Contract for Civil Engineering Works (CE 2011) by categorising all clauses into six (6) main categories. Understanding of CE 2011 Conditions of Contract is essential for the contract administrative works during the construction and post construction. Unwarranted disputes can be avoided with the parties' understanding of their respective duties, rights and obligations expressly stipulated in CE 2011.
